Clause 1: Basic objects of the Friends of Mount Majura Parkcare Group

The basic objects of the group are:

- 1. To promote the wellbeing of the natural and cultural heritage protected within the Mount Majura Nature Reserve (MMNR) through
- 2. Encouraging greater awareness and understanding of the heritage values of the MMNR among FOMM and the wider community:
- **3.** Encouraging the use and enjoyment of the reserve by the community in ways which are consistent with the maintenance and enhancement of the heritage values of MMNR;
- **4.** Cooperating with Territory Government and other agencies (authorities) and interested groups in the sustainable management of MMNR:
- **5.** Identifying threats to the integrity of the heritage values of MMNR, to raise community awareness of, and to seek remedies for these threats;
- **6.** Organising activities to promote the wellbeing of MMNR including, among other things, working parties, and public talks and walks; and
- **7.** Using any other means thought appropriate by FOMM from time to time to achieve the first objective.

Clause 2: Basic objects of the Molonglo Catchment Group Inc.

The basic objects of the group are:

- 1. Provide an umbrella organisation for existing Landcare and other natural resource management (NRM) organisations in the Molonglo Catchment.
- 2. Facilitate the preparation of a community catchment strategy for the Molonglo Catchment, as an agreed framework between key stakeholders for regional delivery of NRM, consistent with the Murrumbidgee Catchment Blueprint, ACT NRM Plan and total catchment principles.
- 3. Facilitate the preparation of a community catchment strategy for the Molonglo Catchment, as an agreed framework between key stakeholders for regional delivery of NRM, consistent with the Murrumbidgee Catchment Blueprint, ACT NRM Plan and total catchment principles.
- **4.** Promote a strengthened partnership between stakeholders in the Molonglo Catchment, to enhance capacity to address NRM issues in the Molonglo Catchment in a collaborative, coordinated and cost-effective manner.
- **5.** Provide support to member groups with sub-catchment planning, strategic project development, funding bids, managing projects and to develop cross-sectoral partnerships and corporate support for projects.
- **6.** Provide a structural link between ACT and NSW groups.
- 7. Provide a central point of contact for the broad community, including information dissemination.
- **8.** Employ and manage a Molonglo Catchment Coordinator to facilitate meeting the above objectives.
