Given that their breeding habitat in Tasmania is being destroyed for woodchips who knows whether we will see them ever again weaving through the canopy of tall box trees? Closer to our doorstep, Majura Parkway threatens to cut its way through grassy woodland and grassland at the eastern foot slopes of Mt Majura and Mt Ainslie. Government has released the Environmental Impact Statement available from the TAMS website for public consultation. The proposed Parkway is not the upgrade of the old Majura road as many of us thought but a new carriage way with two lanes in each direction. It will impact on listed grassy woodland and temperate grassland sites and on known earless dragon and the golden sun moth habitat.

Now, seems that I worked myself into a corner. How to find the right words to invite you to celebrate World Environment Day? May be I can say come along and celebrate our small successes.

### **Working bee: Horehound Blitz and West Slope Challenge**

**When:** Sunday, 28 June, 2009, from 10.00 am to 1.00 pm

**Where:** Meet at the water reservoir behind Rivett / French Streets, Hackett.

**Bring** your favorite weeding tool, preferably household gloves with long cuffs or garden gloves, wear sturdy boots and wrap up warmly. All other tools and material will be provided; hot drinks will keep you warm from inside.

We have planted native shrubs along the drain line behind the water reservoir to assist the restoration of a wild life corridor. At this working bee we will remove as much as possible of the existing weeds to give the seedlings a good start. We will also continue to re-vegetate the bare west slope with local scribbly gums – this will be a true challenge given the steepness of the slope and the shallow soils.
